# 4. FIRST AID MEASURES

#### Description of first aid measures

Indication of any immediate medical attention and special treatment needed Notes to physician: Maintain adequate ventilation and oxygenation of the patient. May cause asthma-like (reactive airways) symptoms. Bronchodilators, expectorants, antitussives and corticosteroids may be of help. If lavage is performed, suggest endotracheal and/or esophageal control. Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach. # 5. FIREFIGHTING MEASURES

# Advice for firefighters

# 6. ACCIDENTAL RELEASE MEASURES

# 7. HANDLING AND STORAGE

Use with adequate ventilation. No smoking, open flames or sources of ignition in handling and storage area. Electrically bond and ground all containers and equipment. Containers, even those that have been emptied, can

contain vapors. Do not cut, drill, grind, weld, or perform similar operations on or near empty containers. Never use air pressure for transferring product.
