#### 4.4 SKIN CONTACT:

## SECTION 5. FIRE FIGHTING MEASURES

# SECTION 7. HANDLING AND STORAGE

- 7.1 PRECAUTIONS FOR SAFE HANDLING:
  Electrostatic charge may accumulate and create a hazardous condition when pumping and handling this material. Review all operations which have the potential of generating and accumulating an electrostatic charge and/or a flammable atmosphere (including tank and container filling, splash filling, tank cleaning, sampling, gauging, switch loading, filtering, mixing, agitation, and vacuum truck operations) and use appropriate mitigating procedures.
